

TERMS AND CONDITIONS

1. Wages quoted should be at par with Central Minimum Wages Act [central sphere – agricultural sector – unskilled category] excluding EPF, EDLI, ESI, Service Tax & Contract service charges.
2. Period of Contract shall be one year likely to be extended depend upon the services extended to this centre.
3. The contractor shall provide required number of contract workers as and when indented orally on day to day basis
4. Each contract worker should work minimum 8 hours per day with lunch break of half an hour
5. The contractor should ensure that all the contract labourers get minimum wage as per prevailing rates and other benefits as are also admissible under various labour laws and also in accordance to the latest Government Notification issued by the chief labour officer for fixation of minimum wage rate to contract labourers.
6. The contractor shall make the payment of wages to contract labourers supplied to their respective bank accounts only and in no way cash payment is allowed.
7. The envelope containing the quotation should be sealed and superscribed as “QUOTATION FOR SUPPLY OF CONTRACT LABOUERERS ” with the reference given above indicating the last date. The envelope received without the reference and seal will be summarily rejected.
8. The last date for receipt of quotations is **23.05.2017 upto 2.00 P.M. and same day the quotations will be opened at 3.00 P.M.** in the presence of the tenderers or their authorized agents who desire to be present.
9. The quotations will be rejected which are received after the due date and time.
10. The quotations should be valid at least for 90 days from the date of issue.
11. The quotations complete in all respects mentioned above and addressed to the undersigned should reach this office either by post or in person.
12. The undersigned reserves the right to accept or reject in full or any part thereof, any quotation without assigning any reason.
13. Quotations should be submitted in duplicate.
14. The bidder shall furnish EMD @ 2% of the total value of the contract (for 3360 appr., Mandays).The EMD shall be submitted only in form of Demand Draft from Any Nationalized Bank drawn in favour of Director, NSSO payable at Hunsur Branch
15. The quotations should be submitted in the letter heads of the parties and the letter head Should contain KST/CST Reg.No./TIN/PAN No.etc.
