Sub: Calling sealed quotations for supply of Farm Yard Manure (12 MT) -Reg.

It is to inform that, the sealed quotations are invited from the interested parties for supply of **12 MT Farm Yard Manure (FYM)** for the use of mulberry garden **at P<sub>2</sub> Basic Seed farm, NSSO, Central Silk Board, Haresamudram, Madakasira - 515301, Anantapur-Dist (AP)** as per the specifications mentioned below.

**FARM YARD MANURE: to supply 12.00 MT during June, 2017**

(The Farm Yard Manure should be decomposed/enriched and having not more than 30% of moisture and free from soil, sand, stones, plastic materials, other foreign materials etc. The rate quoted should include the loading, un-loading, transportation and the weighment of the load with weigh slip at the time of supply of the material).

**TERMS AND CONDITIONS:**

1. The successful bidder should be ready to supply the FYM in the month as mentioned above at the same rate quoted by him. He should produce the material (FYM) weighment slip for the conformity of the quantity supplied.
2. The rates should be excluding taxes and other Govt. levies. The taxes and other Govt. levies should be mentioned separately with % where such taxes are applicable.
3. The quotations must contain the detailed information on the quantity, quality, loading/un-loading and transportation charges etc.,
4. The envelope containing quotations should be sealed and superscribed as "Quotation for supply of FARM YARD MANURE" and the envelope received without the superscription and seal will be summarily rejected.
5. The last date and time for receipt of the quotations is **26-05-2017 up to 3.00 pm** and the quotations received after the due date and time will be rejected.

6. The quotations will be opened on the same date i.e. on **26-05-2017 at 4.30pm** at this office in presence of the tenderes or their authorized representative who desire to be present.
7. The payment will not be made either in cash or in advance. The party interested to quote the rate should supply the FYM on credit basis.

9. The payment of the bill will be settled promptly but only on receipt of the material as specified above and material will be rejected if found not in accordance with specifications.
