**TERMS AND CONDITIONS:**

Validity	Rate quoted should not be lesser than the minimum wages prescribed under rules & valid for a period of ONE year from the date of quotation. However, the rate of VDA will change as and when Central Govt. revises the rates.
Providing Man-power	As and when indented orally or telephonically or through messenger on day-to-day basis.
Payment	Will be settled once in a month on disbursement of the wages to the concerned labourers before 5 <sup>th</sup> of every month and on submission of bill along with copies of acquittance, payment of obligatory remittances to concerned department i.e. EPF / ESI for of the particular month etc.
