TERMS & CONDITION FOR DISPOSAL OF DRIED SISSEO LOG TIMBER

- Interested parties may inspect the sissoo timber logs at SSPC, CSB, Kalitha, Birbhum, office premises in all working days between 10.30 am to 4.30 pm.
- Sissoo timber log will be disposed off on “AS IS WHERE IS BASIS”
- Earnest Money Deposit (EMD) of Rs.1000.00 (Rupees one thousand only) should be deposited by cash for registration of name of parties.
- Sealed tender/s, address to the Scientist-D, **Silkworm Seed Production Centre, National Silkworm Seed Organization, Central Silk Board, Kalitha, Via-Nalhati, Dist-Birbhum-731220, Birbhum (WB) should be submitted, superscribing the “Disposal of Sissoo timber logs” on the left side top of the envelop to reach this office by 01.00 pm on or before 25.7.2018.**
- No tender will be allowed to Participate in the public action without payment of the required EMD.
- Simultaneously public auction of the above said sissoo timber logs will also be conducted on 25.7.2018 at 2.30 p.m. in the aforesaid office premises and interested parties may participate after registration of their names by paying the EMD of Rs.1000/-.
- Parties who have submitted tender will required EMD of Rs.1000/- and wish to participate in public auction also should separately tender the required EMD amount of Rs.1000/-in cash before the commencement of auction.
- After completion of public auction, the sealed tenders received before the due date and time will be opened in the presence of both tenderers and bidders, who choose to be present.
- Only highest bids among the tenderers or public auctioneers, which are more advantageous to the Board, will be accepted.

- The highest bidder to lift the said items within ten days from the sale of receipt of order by depositing full and final amount of bid value, in case the successful bidder fails to lift the sissoo timber log within the stipulated time or deposit full amount, the order will stand cancelled and the bid security will be forfeited.
- TDS/GST, if applicable will be charged extra as per applicable rates. PAN no. should be quoted, if TDS is applicable
