C I R C U L A R

Sub: Enhancement of Variable Dearness Allowance (VDA) for Skilled Farm Workers/Time Scale Farm Workers of CSB with effect from 01.10.2020 - Reg.

In continuation to this Office Circulars of even number dated 28.05.2020 & 29.05.2020 on the subject cited above, it is to inform that the Government of India has notified the revised rates of VDA for those engaged in Agriculture Sector vide order dated 12.10.2020. Accordingly, the approval of the Competent Authority is hereby conveyed for revision of Variable Dearness Allowance to Skilled Farm Workers(SFW)/Time Scale Farm Workers (TSFW unskilled) of CSB [who have not been conferred Temporary Status Scheme].

2. Therefore, The VDA has been enhanced by ₹08.00 per day w.e.f. 01.10.2020 for Area "A", ₹07.00 per day for Area "B" & ₹07.00 per day for Area "C" and therefore the Skilled Farm Workers working in different Units of CSB all over India shall get enhanced Variable Dearness Allowance w.e.f. 01.10.2020 as under:-



Similarly, the VDA has been enhanced by ₹07.00 per day w.e.f. 01.10.2020 for Area "A", ₹06.00 per day for Area "B" & ₹06.00 per day for Area "C" and therefore the Time Scale Farm Workers (Un-Skilled) working in different Units of CSB all over India shall get enhanced Variable Dearness Allowance w. e. f. 01.10.2020 as under:-
