With reference to the subject cited above, this office requires one vehicle [TATA SUMO/ ETIOS/ SWIFT/ SWIFT DESIRE] for REC, Krishnagiri, Central Silk Board for Krishnagiri Mega Cluster Promotion Programme (CPP) activities in and around 120 km radius of Krishnagiri on monthly contract basis for a long term programme with the following terms and conditions from September, 2022 to March, 2023.


1. Hiring of vehicle is on Kilo Meter basis only.
2. Total number of days vehicle is required in a month will be 20 days
3. The monthly usage will be 3000 Km and 200 hours of duty. However, the number of Km may vary and payment will be based on the number of km used in that month.
4. If usage extends as specified above, will be charged on kilometer basis and if the usage exceeds 200 hours, the excess duration shall be paid on hourly basis.
5. The rate quoted shall be all inclusive including driver's bata, Toll fee, taxes etc.
6. The hired vehicle shall not be older than 5-8 years, should have yellow board and also in good running condition.

7. In case of break down, the vehicle shall be replaced in less than 24 hours at the cost of the service provider or will be adjusted on monthly rental of the vehicle
8. The authority reserves the right to terminate the contract if the services are not satisfactory and hampers the official work.
9. The vehicle shall run from the Head Quarter of the cluster and movemet of the vehicle restricted to only cluster area.
10. The vehicle and the driver should have valid documents such as Aadhaar Card/ PAN, valid driving license, RC Book, Emission Test Certificate, Vehicle Insurance etc.
11. The competent authority will finalize on hiring of vehicles
12. Quotation should be sent by Registered Post/ Speed Post only.
13. The vehicle provider should have PAN number registered under CGST & SGST. TDS (Tax Deduction at Source) will be effected at the time of payment under the rule 194-C of TDS rate chart.
14. After issuing the vehicle approval for hiring, agreement to be made up to March, 2023 with the vehicle provider to provide the vehicle for the agreement period. If discontinued to provide vehicle the penal charges to be framed against the vehicle provider @ 10%.
15. The undersigned reserves the right to reject in part or in full any quotation which will not comply with the terms and conditions.

If interested and accepted the above terms and conditions, you are advised to submit the quotation in sealed cover scribing "Quotation for Hiring Vehicle". The last date for receipt of the quotation by register post is up to 3.00 P.M. on 5.08.2022. The quotations received after the due date and time will not be considered.
