OFFICE ORDER

Subject: Preventive measures to check the spread of Coronavirus (COVID-19) for the Offices in the State of Karnataka – regarding.

Please refer to this Office Order of even number dated 5th June, 2021 regarding preventive measures to check the spread of Coronavirus (COVID-19).

The Government of Karnataka has issued revised guidelines in Order No. RD 158 TNR 2020 dated 11th June, 2021 which will remain in force upto 06.00 AM of 21st June, 2021 for strict implementation (copy enclosed) wherein certain additional activities (relaxation) have been permitted **except** in **eleven** (11) identified districts mentioned in Paragraph 5 of the said Order.

Consequently in those districts where such relaxations have been allowed shall resume Office work and follow the Roster of Attendance as per DoPT OMs No.11013/9/2014-Estt.A-III dated 6th May, 2021 & 28th May, 2021 until further revised ensuring that the percentage of attendance does not exceed the limits prescribed by the State Government. This arrangement of maintenance of attendance will, however, be without violating the norms of social distancing and other mandatory requirements like use of mask and sanitizer as per advisory issued by Ministry of Home Affairs and Ministry of Health & Family Welfare from time to time.

The earlier instructions issued vide ibid Office Order dated 22nd May, & 27th April, 2021 shall continue with regard to closure of Offices of CSB in Karnataka State in the Districts identified in paragraph 5 in the revised guidelines dated 11th June (ibid) upto 06.00 AM of 21st June, 2021. The essential activities mentioned in ibid Office Order dated 27th April, 2021 and instructions regarding preventive measures to check the spread of the pandemic, work from home, attendance, vaccination of all Officials of CSB etc. will continue in all offices of CSB in the State of Karnataka.

Divisional & Sectional Heads of Offices are advised to ensure that Video Conference/Webinars/Online Meetings are held in the ensuing week so that urgent pending tasks are attended to by the Officials working from Home. A record of such work may be maintained by the officials who should be available on Phone/Email etc and seek instructions from superior officers if required to attend office.

Officials are advised not to leave their Headquarters during this phase. In case of exigencies Officials may be required to attend Office by following COVID Appropriate Behaviour/Containment Zone restrictions etc.

ORDER

Whereas, the State Executive Committee has issued revised guidelines to break the chain of COVID 19 transmission in the State, vide Order No. RD 158 TNR 2020, dated 07-05-2021 and further amendments to the said guidelines were issued vide Addendums 1 to 10. The State Executive Committee vide orders of even number dated 21-05-2021 and 03-05-2021 has further extended the implementation of the revised guidelines and related addendums upto 6 am of 14-06-2021.

And Whereas, the situation of COVID 19 in the State has been reviewed and it is observed that the strict implementation of the aforementioned guidelines has led to a declining trend in the number of new cases and positivity rate across the State.

And Whereas, the health experts has suggested that opening of economic and other activities be allowed in a graded manner after assessing the local situation and to continue with the appropriate containment and surveillance measures to fully overcome the pandemic in the State.

And Whereas, the Ministry of Home Affairs vide Order No.40-3/2020-DM-I(A), dated 27-05-2021, has directed the States to ensure compliance to the containment measures for COVID-19, as conveyed vide Ministry of Health and Family Welfare DO No.Z.28015/85/2021-DM Cell dated 25-04-2021 until 30-06-2021.

Now, therefore, in exercise of the powers conferred under the Section 24 of the Disaster Management Act, 2005, the undersigned, in the capacity of the Chairman, State Executive Committee, hereby directs that the revised guidelines to break the chain of COVID 19 transmission in the State issued vide Order No. RD 158 TNR 2020, dated 07-05-2021 and further amendments to the said guidelines issued vide Addendums 1 to 10 will continue in districts having high positivity rates, viz, Chikkamagaluru, Shivamogga, Davanagere, Mysuru, Chamarajanagara, Hassan, Dakshina Kannada, Bengaluru Rural, Mandya, Belagavi and Kodagu districts .

In rest of the districts in the State certain additional activities (relaxations), as set out below, to the said guidelines are permitted. These measures will come into effect from 6 am on 14-06-2021 and will be in force including and upto 6 am of 21-06-2021, for strict implementation by Chief

Commissioner BBMP, Police Commissioners, District Deputy Commissioners, Superintendents of Police, and other Heads of Departments and Authorities.

- All production units/establishment/industries are permitted to function with 50% of their staff strength strictly adhering to COVID appropriate behaviour. However, production units/establishments/industries engaged in Garment manufacturing are permitted to function with 30% of their staff strength strictly adhering to COVID appropriate behaviour.
- Shops dealing with food, groceries, fruits and vegetables, meat and fish, dairy and milk booths, and animal fodder shall be allowed to function from 6 am to 2 pm. Street vendors allowed to function from 6 am to 2 pm. Public Distribution System shops are allowed from 6 am to 2 pm. Standalone liquor shops and outlets, take away only, allowed from 6 am to 2 pm. Home delivery of all items shall be encouraged 24x7 to minimize movement of individuals outside their homes. Operations shall be subject to adhering to National Directives for COVID 19 management.
- All Construction activities/repair works including shops/establishments dealing with construction material, especially cement and steel, permitted outside containment zone adhering to COVID appropriate behaviour.
- Parks permitted to open from 5 am to 10 am for walking and jogging purpose strictly adhering to COVID appropriate behavior, but no group activities will be permitted.
- Taxis, and auto rickshaws are permitted to operate and can carry maximum of 2 passengers only.
- In addition to already operating Government offices, the following Government offices are also permitted to function with 50% of their staff: Agriculture and allied offices, PWD, Housing, RTOs, Cooperation, NABARD and offices of Department of Revenue, Government of India.
- Skill trainings pertaining to Health Sector permitted.
- Optical shops permitted to function from 6 am to 2 pm.
- **Night Curfew** will continue to be imposed from 7 pm to 5 am as per the guidelines annexed as Annexure A.
- There shall be **weekend curfew** from Friday 7 pm to Monday 5 am as per the guidelines annexed as Annexure B.

Guidelines for night curfew

1. The movement of individuals shall remain strictly prohibited between 07.00 pm to 5.00 am, except for essential activities.
2. Patients and their attendants/persons requiring emergency need for movement shall be allowed to move.
3. All industries/companies which require operations at night shall be permitted to operate. Movement of employees of such organizations shall be allowed on producing valid ID card/authorization issued by their respective Organization/Institution.
4. Employees and vehicles of Telecom and Internet Service providers shall be allowed movement on producing valid ID card issued by their respective organization/institution. Only essential staff/employees of IT and ITeS companies /organization shall work from office. Rest will work from home.
5. Medical, emergency and essential services including pharmacies shall be fully functional and other commercial activities are prohibited.
6. There shall be no restriction in movement of all types of goods through trucks, goods vehicles or any goods carriers, including empty vehicles. Home delivery of goods and operations of E-Commerce companies are allowed.
7. Movement of trains and air travel are permitted. Movement of Public Transport, private vehicles and taxis to and from airports, railway stations and bus terminals/stops/stands are allowed, for facilitating movement of passengers by air, rail and road. The movement will be allowed only on displaying valid travel documents/tickets.





Guidelines for weekend curfew

Movement of individuals shall remain strictly prohibited between Friday 7 pm to Monday 5 am, except for essential and emergency activities as mentioned below:

1. All State and Central Government offices and their Autonomous Bodies, Corporations, etc, dealing with emergency, essential services and COVID 19 containment and management duties shall be fully functional and officers/personnel of the same shall be allowed unrestricted movement.
2. All Industries/Companies/Organizations dealing with emergency and essential services and requiring operations 24/7 shall be permitted to operate. Movement of employees of such organizations shall be allowed on producing valid ID card issued by their respective Organization/Institution. However, to the extent possible, employees should be encouraged to work from home.
3. Employees and vehicles of Telecom and Internet Service providers shall be allowed movement on producing valid ID card issued by their respective organization/institution. Only essential staff/employees of of IT and ITeS companies /organization shall work from office. Rest will work from home.
4. Patients and their attendants/persons requiring emergency need, eligible people intending to take vaccination shall be allowed movement with minimal proof.
5. Shops dealing with food, groceries, fruits and vegetables, meat and fish, dairy and milk booths, and animal fodder shall be allowed to function from 6 am to 2 pm. Street vendors allowed to function from 6 am to 2 pm. Public Distribution System shops are allowed from 6 am to 2 pm. Standalone liquor shops and outlets, take away only, allowed from 6 am to 2 pm. Home delivery of all items shall be encouraged 24x7 to minimize movement of individuals outside their homes. Operations shall be subject to adhering to National Directives for COVID 19 management.
6. Restaurant and eateries shall be allowed only for take away and home delivery.
7. Movement of trains and air travel are permitted. Movement of Public Transport, private vehicles and taxis to and from airports, railway stations and bus terminals/stops/stands is allowed for facilitating movement of passengers by air, rail and road. The movement will be allowed only on displaying valid travel documents/tickets and strictly adhering to COVID appropriate behavior.

8. Marriages already scheduled are permitted to be conducted at their respective home in a low key manner involving only close family relatives upto 40 people and strictly adhering to COVID 19 appropriate behaviour and guidelines issued by State Government.
9. Cremation/funerals to be allowed strictly adhering to COVID 19 appropriate with maximum of 5 people.
